## Main results of the Council

The Council reached political agreement on three major draft regulations relating to the fisheries sector:

- the TACs for the **Baltic Sea** in 2009, and certain associated measures;
- the TACs for deep water species in 2009 and 2010;
- the TACs for turbot and sprat in the Black Sea for 2009.

The Council also gave its political agreement to the position to be adopted by the Community in the ICCAT, in particular concerning the bluefin tuna stock.

The Council continued to work on a proposal to distribute fruit and vegetables in schools and on the "Health Check" of the Common Agricultural Policy, with a view to reaching agreement by the end of the year.

The Commission submitted to the Council a proposal to combat the illegal trade in timber.

### **ITEMS DEBATED**

## **BALTIC SEA**

The Council reached unanimous political agreement on the fishing opportunities and associated conditions applicable for certain Baltic Sea fish stocks for 2009 (12720/08).

This item will be included, following finalisation by the Legal/Linguistic Experts, in part "A" of the agenda for a forthcoming Council meeting.

The proposal lays down, for 2009, the TAC levels and quotas for certain Baltic Sea stocks, the associated fishing effort for Baltic cod stocks and certain restrictions on the fishing of flounder (*Platichthys flesus*) and turbot (*Psetta maxima*).

The agreement primarily concerned the total allowable catches (TACs) and fishing quotas for Member States in the Baltic region, the main changes to which – in terms of reduction, increase or roll-over of TACs as compared with 2008 – are summarised in the table below.

In accordance with the multiannual plan applicable to stocks of Baltic **cod** (*Gadhus morua*) adopted on 18 September 2007<sup>1</sup>, the Council endorsed a **15** % **increase** in the TACs in the **Eastern** Baltic, in view of the marked improvement in the stock status and a **15** % **reduction** in the Western Baltic where the species is still vulnerable.

For herring (*Clupea harengus*), it was decided to **reduce** the TAC by **15** % for the **Eastern** Baltic and by **39** % for the Western Baltic<sup>2</sup>.

Measures to limit fishing effort were also decided on, in particular:

- a maximum number of days absent from port of **201**<sup>3</sup> days in subdivisions 22-24 (Western Baltic) and **160**<sup>4</sup> days in subdivisions 25-27, i.e. a 10 % reduction in both zones.
- the Commission also proposes continuing to apply the transitional technical measures adopted in 2007 prohibiting retention on board of flounder and turbot during certain periods and in specific subdivisions

Consultation of the Parliament is not required.

A multiannual recovery plan for the pelagic species in the Baltic is shortly to be submitted to the Council by the Commission.

Excluding the period 1 to 30 April, when Article 8(1)(a) of Regulation (EC) No 1098/2007 applies.

#### TAC 2009 – 2010 FOR DEEP WATER SPECIES

The Council reached a unanimous political agreement on the basis of a Presidency compromise, drawn up in agreement with the Commission, concerning a draft Regulation fixing the 2009 and 2010 TACs and quotas for certain stocks of deep water fish<sup>1</sup> such as certain deep water sharks, the black scabbardfish (*Aphanopus carbo*), orange roughy (*Hoplosthetus atlanticus*) and forkbeards (*Phycis blennoides*). The Council will adopt this Regulation, following finalisation by the legal/linguistic experts, at one of its forthcoming meetings.

The main elements of the Presidency compromise endorsed by the Commission are as follows:

- as regards deep-sea sharks<sup>2</sup>, in Community waters and waters not under the sovereignty or jurisdiction of third countries of zones V, VI, VII, VIII, IX, X et XII, two footnotes will be added: for 2009, it will be specified that direct fishing is prohibited and that only by-catches are authorised; for 2010, it will be permitted to fish as by-catches only a maximum of 10 % of national quotas for 2009;
- a comparative table of TACs is given below;
- as regards roundnose grenadier (*Coryphaenoides rupestris*) in Community waters and waters not under the sovereignty or jurisdiction of third countries of zones VIII, IX, X, XII et XIV, a degree of flexibility is allowed for, so that 8 % of the national quota allocated to Member States in these zones can be fished in zones Vb and VI.

For 2007 and 2008, fishing opportunities for deep water species were fixed in Council Regulation (EC) No 2015/2006 of 19 December 2006 (OJ L 384, 29.12.2006, p. 28).

For the purposes of the Regulation, "deep-sea sharks" refers to the following species: Apristuris spp.; Centrophorus granulosus; Centrophorus squamosus; Centroscymnus coelolepis; Centroscymnus crepidater; Deania calceus; Centroscyllium fabricii; Dalatias licha, Etmopterus princeps, Etmopterus spinax, Galeus melastomus, Galeus murinus, Somniosus microcephalus.

- as regards red seabream (*Pagellus bogaraveo*) in Community waters and waters not under the sovereignty or jurisdiction of third countries of zones VI, VII, VIII, IX and X, two footnotes will refer to a minimum landing size for this stock of 30 cm for 2009 and 35 cm for 2010. An exemption is allowed, however, for zone X and a tolerance of 15 % below the minimum size for the other zones in 2010.
- the Commission has stated its intention of aligning fishing effort for these species with the catch limitations thus decided on and will propose, in the regulation, annual TACs and quotas:
  - a 10 % reduction in the fishing effort in order to comply with the international compromise reached in the NEAFC<sup>1</sup>;
  - a detailed revision of Regulation No 2347/2002 in the course of 2009, including new fishing effort limitations for vessels fishing for deep water species.

The International Council for the Exploration of the Sea (ICES) issues scientific opinions every other year (even years) on deep water stocks. The last opinion was delivered in June 2008. It indicates that the deep water species which are most heavily exploited are being fished in an unsustainable manner, and the ICES has recommended immediate reductions in established deep water fisheries, unless they can be shown to be sustainable. No deep water fishery currently fulfils this criterion.

A minimum landing size is set at 30 cm (total length) for 2009 and 35 cm (total length) for 2010. In 2010, however, 10% of catches may be between 30 and 35 cm. Up to 10% of the quota for 2009 may be caught in December 2010.

## **BLACK SEA**

The Council reached unanimous political agreement on a draft Regulation fixing the fishing opportunities and the conditions relating thereto for certain fish stocks applicable in the Black Sea for 2009 (13529/08).

After finalisation by the legal/linguistic experts, the proposal will be adopted as an "A" item at a forthcoming meeting of the Council.

The Council agreed on an unchanged TAC of 100 tonnes for turbot (*Psetta maxima*) – provisionally shared equally between Bulgaria and Romania – and a TAC of 12750 tonnes for sprat (*Sprattus sprattus*), a 15 % reduction compared with 2008.

The Regulation provides for cooperation with third countries bordering the Black Sea.

Consultation of the European Parliament is not required<sup>1</sup>.

## PREPARATION FOR THE 16TH ICCAT ANNUAL MEETING

The Council reached unanimous political agreement on the position that the Community should adopt in the International Commission for the Conservation of Atlantic Tunas (ICCAT), the 16th meeting of which will be held in Marrakech from 17 to 24 November.

The essential features of the negotiation, both within the Community and with the other ICCAT Contracting Parties, basically concern the Bluefin Tuna Recovery Plan, overcapacity (fleet and cages), exceptions to the minimum landing size, the length of the season and certain aspects of monitoring.

In accordance with Article 300(2) of the EC Treaty, the Community position within regional fisheries organisations called upon to adopt decisions having legal effects is decided by the Council acting by qualified majority on a Commission proposal.

## **EU/NORWAY FISHERIES: ANNUAL CONSULTATIONS FOR 2009**

The Council took note of the information provided by Mr Joe Borg, Member of the Commission, and of the Ministers' reactions concerning the first round of consultations between the Community and Norway which will take place in Bergen from 4 to 7 November. The second round of consultations will be held in Brussels from 24 to 28 November.

This matter will be debated in the Council again on 18 and 19 November.

## INTRODUCTION OF TIMBER ONTO THE COMMUNITY MARKET

The Commission presented to the Council the proposal adopted on 17 October aimed at imposing certain obligations on operators who place timber and timber products on the Community market, in order to reduce the risk of introducing timber and timber products from illegal logging (14482/08).

Timber traders will have to obtain sufficient guarantees concerning the compliance of their products with the legislation applicable in the country of origin.

Apart from the clear message that the proposal sends out to operators who wish to have access to the Community market, incentives to better legal and sustainable forest management will thereby be reinforced, particularly in developing countries that wish to maintain and/or develop their exports of forestry products to the EU.

## **HEALTH CHECK OF THE COMMON AGRICULTURAL POLICY (CAP)**

The Council continued its work with a view to reaching political agreement by the end of the year on the "Health Check" of the CAP, which underwent reform in 2003-2004 (9656/08).

Parliament expects to deliver its (consultative) opinion on 19 November.

## FRUIT AND VEGETABLES IN SCHOOLS

The Council noted the views expressed by Ministers, and the Commission representative's comments, on a proposal designed to allow co-financing of a scheme to distribute free fruit and vegetables in schools (11380/08).

The proposal met with very broad consensus among Member States on its aim of promoting the consumption of fruit and vegetables from a very early age and thus establishing healthy eating habits which will contribute to the fight against obesity.

The Council instructed the Special Committee on Agriculture to continue its work so that the Council could adopt the Regulation by the end of the year.

Parliament expects to deliver its (consultative) opinion on 19 November.

## **OTHER BUSINESS**

(a) Crisis in the market for apples for processing in some Central European Member States – joint request by the Hungarian and Polish delegations

(*13321/08*)

The Council noted the critical situation in the apple processing sector as presented by Hungary and Poland.

The Commission representative invited the Member States concerned to make the fullest use of the provisions of the common market organisation for fruit and vegetables, in particular as regards producer and interbranch organisations.

(b) Conclusions of the 23rd Conference of EU Paying Agencies (Ljubljana, 28-31 May 2008) – Request by the Slovenian delegation

The Council noted the conclusions of the 23rd Conference of EU Paying Agencies convened by the Slovenian Presidency in Ljubljana from 28 to 31 May 2008 (14105/08).

It also noted the requests by the Czech, Netherlands, Danish, Latvian, German and United Kingdom delegations for consideration to be given to ways of simplifying the current procedures and the Commission's cautious response concerning the need to maintain an effective system for checking payments<sup>1</sup>.

(c) Green Paper on agricultural product quality: product standards, farming requirements and quality schemes – Information from the Commission

The Council noted the information supplied by the Commission on the Green Paper on agricultural product quality (<u>14358/08</u>), and the preliminary response of some delegations, pending a detailed discussion of the subject.

The Czech delegation informed the Council of a conference to be held on this topic on 12 and 13 March 2009 in Prague.

## (d) Difficult situation in agriculture – Request by the Polish delegation

The Council noted the difficult situation in some sectors of agriculture, especially the cereals and dairy sectors, reported by the Polish delegation, seconded by the Hungarian and Romanian delegations (14623/08).

The Greek and Spanish delegations reported economic difficulties in the livestock sector.

The Commission stated that it was monitoring developments in the markets very closely in order to take the measures which would be most appropriate to the circumstances.

## (e) Policy on bluetongue – Request by the Presidency

The Council noted the worrying situation referred to by the Presidency, given the appearance of a new serotype (6) of bluetongue in the Netherlands, and the need to adopt a common strategy on the matter<sup>1</sup>.

The Netherlands delegation said it would supply all technical information at the meeting of the Standing Committee on the Food Chain and Animal Health on 28 October. It also announced its intention of working together with the Commission to produce a dual vaccine<sup>2</sup> with a view to emergency vaccination.

Mr Joe Borg, representing Androula Vassiliou, the Commission Member responsible for health and consumer protection, pointed out that EUR 136 million had been spent on preventing and combating this epizootic in 2008 and that the Commission was prepared to play its part in 2009, within the framework of national programmes to combat the disease.

He announced the possibility of additional aid – details of which would be known in the coming days – and hoped that Member States would ensure the most cost-effective use of these funds. Lastly, he requested delegations to maintain the strict surveillance currently in place and the restrictions on movements it entailed, which were of crucial importance in confining the outbreak.

## **AGRICULTURE**

## Milk quotas - Council conclusions

The Council adopted the following conclusions:

#### "THE COUNCIL OF THE EUROPEAN UNION

- (1) WELCOMES the Special Report No 4/2008 of the European Court of Auditors concerning the implementation of milk quotas in the Member States which joined the European Union on 1 May 2004;
- NOTES that the implementation of milk quotas posed a major logistical challenge for the new Member States and that a considerable effort was made to ensure that administrative and control systems were operational in good time, even though these systems were still uneven in quality at the time the audit was carried out in the Member States in question;
- NOTES that most of the shortcomings noted are intrinsic to the system's start-up phase. WELCOMES the significant improvements that the Member States have introduced in years subsequent to the Court's enquiry to address the teething problems encountered in early years, inter alia thanks to the Commission's follow-up;
- (4) RECOGNISES that it is up to the Commission and the Member States to continue to ensure that appropriate corrective action is taken and that proper controls are carried out at the most opportune time;
- (5) UNDERLINES that as a result of the enlargement, milk products have been traded more widely without destabilising the European market and without leading to budgetary drift."

#### Meat and livestock statistics

The Council adopted a Regulation establishing a common legal framework for the production of Community statistics on livestock and meat in Member States, following an agreement at first reading with the European Parliament (3641/08).

The Regulation relates to the provision by the Member States of statistics on pig, bovine, sheep and goat livestock and slaughtering statistics on pigs, bovine animals, sheep, goats and poultry and production forecasts of pig, bovine, sheep and goat meat. The statistics referred to in the Regulation are essentially for the management and evaluation of the common agricultural policy.

Directive 93/23/EEC, 93/24/EEC and 93/25/EEC are repealed.

## **EXTERNAL RELATIONS**

#### **Temporary reception of certain Palestinians**

On the basis of the assessment of the implementation of Common Position 2002/400/CFSP, the Council adopted a Common Position extending for one year the validity of national permits allowing Palestinians who were evacuated from Bethlehem following the siege of the Church of the Nativity by Israeli forces in 2002 to stay in the EU (13426/08).

## Protection of wild birds

The Council adopted a Directive adapting Directive 79/409/EEC on the conservation of wild birds to the regulatory procedure with scrutiny, following agreement at first reading with the Parliament (3666/1/08).
