From net to plate: making control work for Europe's fisheries



In November 2008 the European Commission agreed on a proposal for a regulation setting out a new approach to controlling the EU's fisheries' activities. The aim of the reform is to reverse the current tendency within the sector of fishermen not complying with the rules of the Common Fisheries Policy. This failure to comply with the law is a serious problem, because these rules have been put in place to guarantee the sustainable use of our fisheries.

The film explains the main thrust of the reform of the control of fisheries, based on footage shot during the 2008 bluefin tuna season in the Mediterranean. The film was shot in spring 2008 at the European Commission (Brussels, Belgium), during naval and air inspections at sea south of Sicily (Italy) and during inspections of tuna fattening farms in Limassol (Cyprus).
