## The challenges of fisheries management and how to address them successfully in the new CFP

Marine life is disappearing from our seas and fishermen are struggling to keep their businesses profitable. Fishermen, fishing communities and oceans depend on thriving fish stocks and healthy marine ecosystems. Protecting fish stocks and marine life is therefore an economic, social and environmental imperative. The Common Fisheries Policy (CFP), which has been in place for three decades, has undergone two reviews and is currently in the midst of the third. As over 72 per cent of the assessed EU fish stocks are overfished and 22 per cent fall outside of safe biological limits (European Commission, 2010) the CFP has certainly failed in its mandate of ensuring that the use of fisheries resources are economically, socially and environmentally viable. As a result, the sustainability of fishing communities as well as the functioning of marine ecosystems remains highly threatened. We need an ambitious reform of Europe's fisheries policy. Successful reform has the potential to create sustainable fisheries, livelihoods and subsequent economic benefits for society as a whole.

WWF cordially invites you to attend a seminar which will address the challenges of fisheries management and the emerging solutions being applied in different European regions which aim to ensure sustainable stocks and long-term social and economic profitability. The seminar will feature the diverse and unique perspective of key stakeholders such as the European Commission, Members of the European Parliament, Member States Government Representatives, fisherman, seafood market industry and science representatives.

There will also be a lunch reception hosted by WWF, AIPCE, Eurocommerce, Euro Coop and Euro-Toques\* - an alliance advocating for a real reform of the Common Fisheries Policy (CFP).
